

# GUIDE FOR AUTHORS

The Revista de Contabilidad-Spanish Accounting Review (RC-SAR) is the international research journal of the Spanish Association of Accounting Academics [Asociación Española de Profesores Universitarios de Contabilidad]. It has been published uninterruptedly since 1997.

Established to further the development of accounting knowledge, RC-SAR is a forum for the publication and dissemination of high quality research manuscripts. Aware of the need for research that promotes critical analysis of theories, research issues, policy and practice, RC-SAR functions as a pluralist, flexible and open journal, not only with regard to the subject matter, but also with respect to the research paradigms and methodologies of the articles that it publishes. RC-SAR publishes both empirical and theoretical papers, often with interdisciplinary perspectives, which offer new perspectives in accounting research from a national, international or organizational standpoint. Submission of the article means that the authors accept the editorial policy and rules for the review and publication of research works in the RC-SAR. The points of view and the opinions expressed in the articles published in the Review are wholly those of the author and will not necessarily reflect those of the Editorial Team. Both the Editorial Board and ASEPUC decline any responsibility for the content of the material that is published.

## Editorial Process

If the work submitted meets the publication guidelines, the RC-SAR editorial team will assign it to two experts in its specific area of research and/or methodology, who will conduct an anonymous review of the work (double-blind peer review).

## Conflict of interest

All authors are requested to disclose any actual or potential conflict of interest including any financial, personal or other relationships with other people or organizations within three years of beginning the submitted work that could inappropriately influence, or be perceived to influence, their work. ## Submission declaration and verification

Submission of an article implies that the work described has not been published previously (except in the form of an abstract, part of a conference or thesis, an electronic preprint or, as a congress contribution), that it is not under consideration for publication elsewhere, that its publication is approved by all authors and tacitly or explicitly by the responsible authorities where the work was carried out, and that, if accepted, it will not be published elsewhere in the same form, in English or in any other language, including electronically without the written consent of the copyright-holder.

## Changes to authorship

This policy concerns the addition, deletion, or rearrangement of author names in the authorship of accepted manuscripts:

### ***Before the accepted manuscript is published in an online issue***

Requests to add or remove an author, or to rearrange the author names, must be sent to the Journal Manager from the corresponding author of the accepted manuscript and must include: (a) the reason the name should be added or removed, or the author names rearranged and (b) written confirmation (e-mail, fax, letter) from all authors that they agree with the addition, removal or rearrangement. In the case of addition or removal of authors, this includes confirmation from the author being added or removed. Requests that are not sent by the corresponding author will be forwarded by the Journal Manager to the corresponding author, who must follow the procedure as described above. Note that: (1) Journal Managers will inform the Journal Editors of any such requests and (2) publication of the accepted manuscript in an online issue is suspended until authorship has been agreed.

### ***After the accepted manuscript is published in an online issue***

Any requests to add, delete, or rearrange author names in an article published in an online issue will follow the same policies as noted above and result in a corrigendum.

## Copyright

RCSAR is Open Access and its contents can be read and downloaded free of charge, without incurring any costs for the author.

Upon acceptance of an article, authors will be asked to complete an 'Exclusive License Agreement' (for more information see

<http://www.elsevier.com/OAauthoragreement> and <http://www.elsevier.com/copyright>). In this agreement the author accepts the transfer of copyright of the article to the ASEPUC, with the re-use of its contents being defined by the licence of use, **CC BY-NC-ND (Creative Commons Attribution-NonCommercial-NoDerivatives License)**, which allows the article to be read, printed and downloaded, extracted and re-use extracts in other articles, as well as to distribute it in Open Access repositories, and translate it for personal use. This licence does not permit commercial use of the article.

If excerpts from other copyrighted works are included, the author(s) must obtain written permission from the copyright owners and credit the source(s) in the article. Elsevier has preprinted forms for use by authors in these cases: please consult <http://www.elsevier.com/permissions>.

## Role of the funding source

Authors are requested to identify who provided financial support for the conduct of the research and/or preparation of the article and to briefly describe the role of the sponsor(s), if

any, in study design; in the collection, analysis and interpretation of data; in the writing of the report; and in the decision to submit the article for publication. If the funding source(s) had no such involvement then this should be stated.

## Presentation and structure of papers

RC-SAR admits works written in Spanish and in English. Original manuscripts should be submitted to RC-SAR through the Elsevier editorial system (<http://ees.elsevier.com/rcsar/>).

Separate files must be submitted for: a) the details of identification, contact and affiliation of the author/s (first page), b) the body of the article (called anonymous manuscript in the application), c) the Tables (when they are not in text format), and d) the Figures. Furthermore, declarations must be entered in the application on any external funding of the work and conflicts of interests that, for convenience, should be prepared for "cutting and pasting". Also, in the application the authors may suggest reviewers and indicate those who should not examine their manuscript. RC-SAR is not obliged to follow their preferences, but will try to accommodate them as far as possible.

The **first page** must contain the title in Spanish and in English, the authors, department, institution, city and country in which they practice their profession. It must indicate one of the authors as corresponding author to maintain contact with RC-SAR and include a postal address, telephone number and e-mail address. If the work has received external funding, the funding institution and the programme or project financed. This first page also has to include the acknowledgements, if there are any. With the exception of the title, none of the rest of the details will be included in the rest of the files, or any other that might identify the authors directly or indirectly.

The **body of the article** (or manuscript) starts with a **first section** that must contain the title (in Spanish and in English), the abstract/s and the key words. The key words (approximately 5) will be suitable for identifying the work in repositories and data bases. In the articles written in Spanish, the abstract and key words must be submitted in Spanish and English. In the articles written in English, the abstract and key words may be submitted in English only. The Abstract will be structured. It will consist of set of short sentences that describe the most relevant point of the article in a maximum of 300 words and the following sections: Background, Aims, Methods and Data, Results, and Discussion and/or Conclusions. If appropriate, the most relevant implications may also be included. When this structure is considered appropriate (for example, critical articles or regulations, reviews, case studies...), it is recommended to include, the aim or objective, synthesis of the main arguments and the fundamental conclusions, as an abstract, with a maximum of 300 words.

The **second section** of the body of the article (or manuscript) must contain the text of the article. At the end, it will include the bibliography and Tables, when these are in text format. The article must not exceed 10,000 words, including the Bibliography and the Tables.

The **Tables** only need to be submitted in separate files when they are not in text format (for example, PowerPoint, Excel). The **Figures** must have a minimum resolution of 300 dpi and in one of the following formats: JPG, EPS, TIFF, and PDF and MS Office (only in some cases;

consult the Instructions for the Figures). Compressed files may also be sent (.zip, .tar, .tar.gz, and .tgz).

**Manuscript Text.** Where up to 2 authors appear in the bibliographic references used in the text, the first surnames of the authors will be cited, followed by the year of publication. If the number of authors is equal to or more than three, the first surname of the first author will always be cited followed by "et al". If various bibliographic references are cited simultaneously, they will be ordered chronologically (from the oldest to the most recent). A lower case letter will be added to the year to distinguish between various references to the same author and in the same year.

**Bibliography.** The bibliography should appear at the end of the text, with the authors' surnames in alphabetical order. Bibliographic references should follow the format indicated in the examples below (in other cases, the American Psychological Association Bibliographical Reference style should be followed):

The **Digital Object Identifier (DOI)** may be used to cite and link to electronic documents. The DOI consists of a unique alpha-numeric character string which is assigned to a document by the publisher upon the initial electronic publication. The assigned DOI never changes. Therefore, it is an ideal medium for citing a document, particularly 'Articles in press' because they have not yet received their full bibliographic information. If URL format is preferred (that is to say, that the document is cited as, <http://dx.doi.org/10.1016/j.rcsar.2015.01.001> instead of as, doi:10.1016/j.rcsar.2015.01.001).

**Tables and Figures.** In the text it, the place where each one of the Tables and Figures should appear, just has to be indicated. They must be numbered with Arabic numerals in accordance to the order they appear in the text. The Titles or Footnotes that accompany them will describe their content perfectly. The Figures must be submitted in a separate document, each one of them being presented on a different page.

**Footnotes** should be limited to those strictly necessary, and should also be sequentially numbered.

**Mathematical expressions** should be sequentially numbered with numbers between square brackets, justified to the right margin.
